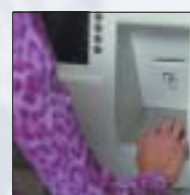


## Q-CashLobby™ 25

## Q-CashLobby 25

Q-CashLobby 25 is specially designed to ensure highest degree of customer security, privacy and comfort in operation. The customer keyboard as well as the card reader are recessed in the customer fascia giving the user full control during the whole transaction.

Q-CashLobby 25 has an intuitive customer interface giving a natural, logical flow of operation. The OPEN/CLOSE indicator, visible at 100 m distance, enables the user to avoid any unnecessary inconvenience.

### DISPENSING VERSATILITY

Q-CashLobby 25 operates with a state-of-the-art friction feed dispenser technology. Up to 5 denominations with a total cassette capacity of up to 15,000 notes is supported in a mixture of new and used notes as well as other media. Self-calibrating sensors and double detect reduces preventive maintenance to a minimum.

### CUSTOMISATION

Q-CashLobby 25 offers a variety of customisation options e.g. a wide range of colours to meet any financial institution's requirements to harmonise with its styling and corporate design. A specially designed shelf is available for convenient placement of a bag or briefcase during transaction processing.

### COST OF OWNERSHIP

The open architecture and adherence to industry and de facto standards of the Q-CashLobby 25 ensures a low cost of ownership. The large screen can be utilised for advertising and marketing campaigns, further expanding the utilisation of the Q-CashLobby 25. Adaptations to different note sizes and denominations can easily be made without replacing any parts. Easy accessed replenishment modules minimises the time consumption for maintenance and service. The floor space required is only 0.4 m<sup>2</sup>.
